The meeting was started with the Name of Allah. The Principal, JCW, who is the Convener of the Steering Committee telephonically informed thatt due to illness, she is unable to attend the meeting. She desired the Director of Works to chair the meeting and proceed accordingly. Therefore, the DOW proceeded with the meeting. He informed the Committee that Pre-Bid Meeting is part of the bidding process, which is scheduled today in order to clarify the queries, if made by the prospective bidders regarding the bidding documents.

Representatives of different bidders at S.No.1 to 5 above, who had not collected the biding documents from the office, were present in the meeting, who introduced themselves one-by-one. Since, the requisite bid documents were not available with the bidders, therefore, the Committee expressed its concern that without having collected the bidding documents how a query can be raised by a bidder and replied on a particular point.

However, the following clarifications were made:

- 1) The bidders shall submit their bids in the manners as prescribed in the bidding documents being issued by the office.
- 2) The bidders shall stamp & sign all volumes / pages of the bid documents.
- 3) After submission of the sealed bids, no further documents will be accepted by the office.
- 4) No above premium is acceptable on the Non Schedule Items included in the Bill of Quantities.
- 5) In the Public Health Work of the Bill of Quantities, approved manufacturers / brands for Item No.3 may be read as mentioned vide S.No.16, "Sanitary Fixtures" at Page-151 of the Volume-II i.e., "Technical Specifications"

- 6) In the last page of the Bill of Quantities, approved manufacturers / brands for Non Schedule Items No.1, 2 & 3 may be read as mentioned vide S.No.23, "Cables & Wires" at Page-152 of the Volume-II i.e., "Technical Specifications"
- 7) Approved manufacturers' list has already been provided in the technical specifications. However, during the execution of work at site, selection / choice of the procuring entity regarding the determination of best quality brand/make will be final.

The meeting was then ended with vote of thanks.
